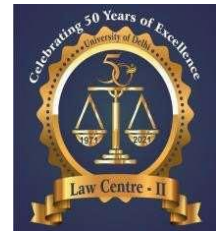

EXECUTIVE MEMBERS AND PARA-LEGAL VOLUNTEERS

COMMON SELECTION EXAMINATION 2026-2027

The Students of the Law Centre-II are hereby informed that Legal Aid Society, LC-II is conducting common selection examination for the Executive Committee and Para-Legal Volunteers for the academic year 2026-27. The examination consists of multiple-choice questions (MCQ). There shall be 50 MCQs wherein 01 mark shall be given to one correct answer and there shall be no negative marking. The students shortlisted on the basis of this examination may be required to appear for a screening test to be conducted by the Delhi State Legal Services Authority (DSLISA) for the selection of Para Legal Volunteers (PLVs)*. The date, time, and venue of the screening test will be notified by the DSLISA in due course. The selection of PLVs shall be made solely on the basis of the screening test and the criteria prescribed by the DSLISA. Law Centre-II has no role in the screening, selection, or training process of PLVs.
