#### Orientation Programme, 2017-18

#### Legal Aid Orientation Programme, 2017

The Legal Aid Orientation Programme 2017 was organised at Law Centre-II on September 19, 2017. Sh. Naveen Gupta, Judicial Officer and Additional Secretary, Delhi State Legal Services Authority and Sh. Jagmohan Singh, Judicial Officer and Secretary, South West District, Delhi State Legal Services Authority addressed the students on the theme Legal Aid: Duty Towards the Society.





#### Para Legal Volunteers (PLV) Training

One of the most important activities of Delhi State Legal Services Authority is to train the students as Para Legal Volunteers (PLVs), who in turn will serve the community after getting the training. The students at Law Centre-II are very enthusiastic to become PLVs. However, DSLSA gives PLV training to a very few students. In order to maintain complete transparency, the Convenor of Legal Aid Committee, Dr. Mahavir Singh with the help of other teachers, conducted a test of all those students who were interested to get PLV training. A record number of 527 students appeared in the test and a merit list was drawn for the purpose of sending their names to DSLSA for training. The Senior Judicial Officers of Delhi gave training to the First Batch of 94 students of Law Centre-II on November 21-22, 2017.

The First lecture under Samvad was delivered by Sh. M.L. Sharma, former IPS Officer and Special Director, Central Bureau of Investigation (CBI). It is a matter of pride that Sh. Sharma is an alumnus of Law Centre-II. Prof. Poonam Saxena, Hon'ble Vice-Chancellor, National Law University, Jodhpur delivered Second lecture in the series on Emerging Trends in Family Law on September 16, 2017. The lecture was attended by students and teachers of the three Centres of the Faculty of Law.



The Third lecture under the Lecture Series was delivered by Justice S.N. Jha, former Chief Justice, Jammu and Kashmir High Court and Rajasthan High Court on "Justice Delayed is Justice Denied" on November 14, 2017. Justice Jha shared his experiences and talked extensively on the reasons of justice being delayed in India.
