# Rules

#### I. DATE & PLATFORM OF THE COMPETITION

The oral rounds of the S.K. Puri Memorial International Moot Court – JUSTIFIED'22 (hereinafter, 'the competition') shall be held online from 15th to 17th July 2022, via Zoom Cloud Meetings.

#### II. ORGANISING COMMITTEE

#### A. COMMITTEE MEMBERS

- 1. Prof. Dr. Mahavir Singh Kalon, Professor-In-charge, Law Centre II, shall be the competition administrator.
- 2. The members of the Organising Committee (hereinafter, 'the OC') for the competition are as follows:

#### B. DISCRETIONARY POWERS OF THE OC

- 1. The OC's decision regarding the interpretation of the rules or any other matter related to the competition shall be final and binding.
- 2. In the event it is required, the OC reserves the right to vary, alter, modify or repeal any of the rules of the competition and in the manner deemed

- appropriate by the OC at any time before and/or during the Competition in order to ensure fairness and equality.
- 3. In case of any dispute or conflict, the decision of the OC shall be final and binding.

#### III. ELIGIBILITY

- All students who have been duly enrolled and are pursuing a full-time 3-year LL.B. programme or a 5-year integrated LL.B. programme or LL.M. programme (or international equivalent) from a recognized Indian or Foreign University shall be eligible to participate in the competition.
- 2. Only one team can register from a particular College or Institution for participation.
- 3. Students pursuing Diploma Courses or Certificate Courses are NOT ELGIBLE to participate in the competition.

#### IV. TEAM COMPOSITION

- 1. Each team shall comprise of a maximum number of three members (two speakers and one researcher) or a minimum number of two members (two speakers). In the event a team consists of only 2 members, it shall be mandatory for one of them to also participate as a researcher.
- 2. In the event any change is required in the name of a participant and/or in his/her designation as a speaker or a researcher, the same shall be communicated to the OC via e-mail latest by 2<sup>nd</sup> July 2022, 5:00 P.M. Such change shall not be automatic on sending an e-mail. It may be permitted or rejected by the OC and such decision shall be duly communicated to the participating team.
- 3. Once the competition commences on 15<sup>th</sup> July 2022, no changes in the members of the participating team shall be allowed.
- 4. Once the competition commences on 15<sup>th</sup> July 2022, no interchangeability amongst/between the speakers and/or researcher shall be allowed at any point in the competition unless under exceptional circumstances with the permission of the OC.

#### V. OFFICIAL LANGUAGE

The official language of the competition shall be English, for written as well as oral submissions.

#### VI. RULES REGARDING REGISTRATION

#### A. REGISTRATION THROUGH GOOGLE FORM

- All prospective participating teams shall register for the competition through the <u>Registration Form</u> on or before 15<sup>th</sup> June 2022, 11:59 PM.
  All the required screenshots and scanned copies shall be attached in this form.
- 2. Registration shall not be accepted through any means other than the Registration Form.
- 3. In the Registration Form, the participating team shall indicate the member who shall be an official point of contact for the organisers and such person shall be responsible for all official communication between the OC and the participating team.
- 4. The attachments shall contain the following:
  - i. Scanned copy of the Endorsement letter from college of the participating team.
  - ii. Scanned copy or screenshot of Receipt generated on completion of the electronic transfer of registration fee showing successful transfer in the name of the beneficiary.
- iii. Scanned copies of the Institution/College ID Cards of the participants.
- 5. Account details for payment of registration fee have been mentioned in the Registration Form. Each team intending to register shall pay a registration fee of ₹ 2000/- on or before 15th June 2022, 11:59 P.M. at the link given in the Registration Form. Any additional charges that are incurred in making the electronic transfer are required to be borne by the team itself.

- 6. Registration shall be considered successful only if all the abovementioned requirements are satisfied by a participating team. Teams which have registered successfully shall participate in the oral rounds after submission of memorials subject to the rules of the competition.
- 7. In the event a team notifies the OC of its withdrawal or absence from participation in the competition, such team SHALL NOT be entitled to refund of the registration fee or any amount which has been paid in the registration process.
- 8. Only one registration per college or institution shall be accepted.
- 9. To the teams that register successfully, the OC will acknowledge successful registration. In the event there is any discrepancy in the registration e-mail, the decision of the OC shall be final.
- 10. Each team that registers successfully shall be allotted a Unique Team Code (UTC) by the OC via the official e-mail id. Once the said UTC is allotted to a team, the team must only use such UTC for all future correspondence with the OC and no detail or information personally identifiable with the participants or college or institution including name and/or logo of the college or institute shall be used.
- 11. Submissions of incomplete forms and/or registration via e-mail will not amount to successful registration and shall not be considered. In any such event, the decisions of the OC regarding the mode to deal with such cases shall be final.

## B. ALLOTMENT OF UNIQUE TEAM CODE

- 1. After successful registration, each team shall be allotted a Unique Team Code (hereinafter, 'UTC'), which shall be communicated to them on the email of the Official Contact Person.
- 2. Teams are required to use the UTC in their memorials and oral submissions to identify themselves.
- 3. Use of any other personal identification detail, like name or logo of college anywhere in the memorials or during the oral submissions shall be in breach of Rule VII (D)(4) and shall be penalized accordingly.

#### VII. RULES REGARDING MEMORIAL

#### A. FORMAT AND PRESENTATION OF MEMORIALS

- Memorials for submission will be in soft copy format and shall be on an A4 size page layout.
- 2. The font used in the main text of the memorials shall be Times New Roman, Size 12, with 1.5 line spacing.
- 3. The font of the footnotes in the memorials shall be Times New Roman, Size 10 with 1.0 line spacing. The teams are required to follow the 20th Blue Book Method of Citation for citing any source or authority.
- 4. Each page shall have a margin of 1 inch (2.54cm) on all sides and Justified alignment shall be used throughout.
- 5. Each page shall be clearly numbered with page numbers being provided in the top right corner.
- 6. All memorials shall contain these mandatory sections:
  - a. Cover Page
  - b. Table of Contents
  - c. List of Authorities
  - d. Summary of Facts (must not exceed two pages)
  - e. Statement of Issues
  - f. Summary of Arguments (must not exceed two pages)
  - g. Arguments Advanced
  - h. Prayer

Arguments Advanced and Prayer together shall not exceed 30 pages.

- 8. The **cover page** of every memorial shall be in the format prescribed as follows:
  - i. The UTC must be mentioned in the upper right corner of each memorial in a box. For example, if the UTC is 01, it shall be provided on the cover page on the top right corner as C-01 in the claimant's memorial and R-01 in the respondent's memorial.
  - ii. The name of the Competition shall be mentioned, followed by the name of the forum resolving the dispute.

- iii. The Cause Title must be clearly stated with names of the parties and their capacity i.e., claimant or respondent.
- iv. The Party for which the Memorial is prepared must be mentioned under the cause title as 'WRITTEN SUBMISSIONS ON BEHALF OF CLAIMANT/RESPONDENT'
- v. The cover page of the memorial of the claimant shall have a blue background and the cover page of the memorial of the respondent shall have a red background with the abovementioned layout in the soft copy submissions.
- vi. No team shall mention any personally identifiable detail or information including the logo, the name of the participants or the name of the college/university/institution anywhere in the memorial or else severe penalty shall be imposed on the team in consonance with Rule VII(D)(4) and (6), and Rule X(7).
- vii. No annexures shall be attached with the memorials.
- viii. A team may raise additional issues or grounds of challenge other than the ones mentioned in the moot problem.

#### **B. SUBMISSION OF MEMORIALS**

- 1. Submission of soft copies of the memorials shall be both .doc and .pdf formats. Submissions must only be made via the Google Form.
- 2. Memorials submitted through email shall not be accepted.
- Each team that has duly registered for the competition will be required to submit soft copies of its memorials on the Google Form latest by 11:59 PM on 2<sup>nd</sup> July 2022.
- 4. Memorials submitted after the deadline shall be penalised in accordance with Rule VII(D)(1). No memorial submission shall be accepted after the expiry of 24 hours from the deadline specified otherwise than in exceptional circumstances. In such exceptional circumstances, the decision to accept or reject such memorial shall vest in the OC.

- 5. Each team shall submit a memorial on behalf of each of the parties i.e., one memorial on behalf of the Claimant and one memorial on behalf of the Respondent, in .doc and .pdf formats.
- 6. Each memorial shall be submitted as a separate file and the file name shall have the initial of the party on whose behalf the submissions are being made in the particular memorial followed by the UTC, i.e., 'C-01' for the claimant with UTC as '01' and 'R-01' for the respondent with UTC as '01'.
- 7. No team shall mention any personally identifiable detail or information anywhere in the memorial including the logo or name of the University or the name of the participants.
- 8. A memorial once submitted in the given format shall be considered as final and cannot be revised unless the same is requested under extremely exceptional circumstances and the OC shall allow or reject any such request at its discretion.

#### C. SCORING

#### D. PENALTIES

For all discrepancies and errors in the memorials, the penalty shall be imposed in the manner prescribed hereunder. Regardless of the actual number of penalties, no more than 15 Marks shall be deducted for any errors in the memorial.

#### E. RIGHTS OVER THE MEMORIALS

- 1. Upon completion of the Competition, the OC shall reserve the exclusive right to use the memorials submitted to them, as they deem appropriate. The copyright over the memorials submitted for participation in the Competition is assigned by the participants and shall also vest completely and fully in Law Centre- II, Faculty of Law, University of Delhi.
- 2. The participants shall certify in writing the originality of materials contained therein and shall be responsible for any claim(s) or dispute(s) arising out of the further use and exhibition of these materials.

- 3. Further use and exhibition of these materials, electronically or otherwise, shall be the exclusive right of Law Centre- II, Faculty of Law, University of Delhi, and they shall not be responsible for any liability to any person, for any loss caused by errors or omissions in this collection of information, or for the accuracy, completeness, or adequacy of the information contained in these materials.
- 4. Distribution of these materials on affiliated websites does not constitute consent to any use of this material for commercial redistribution either via the Internet or using some other form of hypertext distribution.

#### VIII. RULES REGARDING ORAL SUBMISSIONS

The competition shall commence on 15<sup>th</sup> July 2022 and conclude on 17<sup>th</sup> July 2022. The Valedictory Ceremony will be held on 17<sup>th</sup> July 2022. The monetary prizes shall be transferred to the winners via RTGS or NEFT. E-certificates will also be sent directly to the participants

#### A. RULES FOR THE ONLINE PLATFORM

- The oral rounds of the competition shall take place via Zoom Cloud Meetings. However, the OC reserves the right to change the online platform to conduct the competition.
- 2. Technological Requirements:
  - a. Participants are to use a stable internet connection (4G or Wi-Fi) during the virtual rounds.
  - b. Participants must use laptops or PCs for the oral rounds. The use of cell phones is prohibited.
  - c. All participants are responsible for logistics and the OC shall not be responsible for any failure with the same.
  - d. Participants are advised to use headphones during the rounds for better sound reception.
  - e. The participants must ensure that any noise or audio other than their voice should not disturb the court proceedings.

- f. The participants should make necessary preparations before entering the meeting room i.e., <u>downloading the Zoom App</u> and ensuring that their device is compatible with the same.
- g. The participants are prohibited from recording the Virtual Courtroom proceedings in any form or manner.
- h. The Invitation Link to the Virtual Courtroom shall be sent to the team on their registered e-mail ID, two hours prior to the round.
- i. The Teams will be e-mailed the soft copy of their opponent's Written Submission prior to the oral rounds.
- j. **Screen Name:** Participants must rename their screen names on Zoom as their position in their team along with their UTC as their username while joining the Virtual Courtroom. For example, if Team 25 is Claimant in Preliminary Round 1, then the screen names shall be 'Speaker 1(C-25)'.

#### 3. Identification Requirements:

- a. Since it is a virtual moot, all participants must bear with them at least one identity document for any probable verification during the Mooting sessions.
- b. The background of the participants on video shall be plain and shall not contain any symbols or any representations.
- c. Only the respective team members, judges, court masters and members of the organizing Moot Court Committee may be present in the Virtual Courtrooms. No faculty designate or observer of participating colleges/institutions/universities shall be allowed to join the virtual mooting sessions.
- 1. In the Virtual Courtrooms, all participants shall keep their videos turned on at all times.
- 2. The participants must keep their microphones muted until they are required to speak.
- 3. The distribution of time between the speakers should be intimated by the team to the Court Master prior to the start of the proceedings. The Court Master shall interrupt the meeting to give a reminder to each speaker at 5

- minutes and 2 minutes before the time allotted, as provided by the teams, is to come to an end.
- 4. In case internet connection of Speaker 1 is lost or if that Speaker faces any other difficulty in connecting, a time limit of 5 minutes will be given to that speaker to reconnect. After 5 minutes are over, Speaker 2 will take over to put forth their arguments. In the meanwhile, Speaker 1 should try to reconnect. However, even after completion of arguments of Speaker 2, if Speaker 1 has not reconnected, the team shall be marked on the basis of arguments put forth by Speaker 2 and Speaker 1 only if he has put forth any arguments before disconnection.
- 5. In case internet connection of Speaker 2 is lost or if that Speaker faces any other difficulty in connecting, a maximum of 5 minutes will be given to reconnect. If that Speaker fails to reconnect, the team shall be marked only on the basis of the arguments put forth by Speaker 1 and Speaker 2 if he has put forth any arguments before disconnection.
- 6. In case the judges face Internet connectivity issues, the time limit of the respective rounds will be adjusted accordingly by the organizer of the round.
- 7. Any other queries will be solved by the Court Master in consultation with the OC.
- 8. The participating teams are not allowed to use any other electronic device other than the one which is being used to participate in the moot, including (but not limited to), tablet computers, mobile phones, smart/digital watches etc. in the Virtual Courtroom during the course of the round, including when the opposite team is addressing arguments. In case a member of a team is found using any such electronic device, the team shall invite a severe penalty which may include disqualification.
- 9. Any problems encountered by the teams should be communicated by the team to the Court Master via the group text feature of the organizer's hosting platform.
- 10. If a team scheduled to take part in a round does not appear within 10 minutes of the scheduled time, the other team shall be allowed to submit ex parte.

- 11. The organizers shall not be held responsible for any glitches arising out of poor network or other technical issues.
- 12. In any case whatsoever, the decision of the OC shall be final.

#### **B. PRELIMINARY ROUNDS**

- 1. Each team shall be required to represent both parties to the problem across the two preliminary rounds. The OC shall, through a seeding process based on the memorial score, pair the teams. The OC shall not disclose the seed rankings at any time
- 2. Each team shall have a maximum of **30 minutes** to advance arguments which include the time for answering questions, rebuttals and surrebuttals.
- 3. Each team is entitled to divide and allocate time to each speaker of the team in the manner it deems fit provided that no speaker shall be allocated less than 10 minutes to advance their arguments. Time division adopted by each team shall be intimated to the Court Master before the commencement of the round.
- 4. The teams must mandatorily reserve a minimum of 2 minutes for rebuttals and sur-rebuttals by the claimant and the respondent respectively and this shall be included within the 30 Minutes time limit.
- 5. Judges may also exercise their discretion in extending the time for advancing of oral arguments and in determining the method of dealing with such extension of time in scoring the team.
- 6. Best Speaker and Second Best Speaker of Preliminary Rounds shall be decided based on the scores of the preliminary rounds.

# C. Quarter Finals

- 1. 8 teams shall qualify for the quarter-final rounds based on their performance in the preliminary rounds in the following manner:
- 2. The 8 teams that win both the preliminary rounds shall qualify for the quarter-final rounds, subject to the following:
  - a. In the event, there are less than 8 teams with two wins across both the preliminary rounds then, in addition to the teams with two wins that qualify for the quarter-final rounds, the teams with one win in

either of the preliminary rounds shall be considered for qualification to the quarter-final rounds. In such a case, the margin by which the team with one win has won the round shall be adjusted against the margin by which such team has lost the other round, based on the total score. The teams which have won by a greater margin than the others shall qualify for the quarter-final rounds.

- b. In the event there are more than 8 teams with two wins across both the preliminary rounds then the total margin by which the winning teams have defeated their opponents in both the rounds, based on the total score, shall be taken into consideration and the 8 teams with the highest total winning margin across the two rounds shall qualify for the quarterfinal rounds.
- c. In the event of a tie between the winning margin of two teams, based on the total score, the memorial scores of the teams shall be considered in order to break the tie. The team with a greater memorial score shall qualify.
- 3. Based on the prescribed rules regarding qualification to the quarter-final round, 8 teams shall qualify for the quarter-final round. The opposing teams shall be decided through a seeding process dependent on the winning margin of the teams in the Preliminary Rounds.
- 4. Each team shall have a maximum of **30 minutes** to advance arguments which include the time for answering questions, rebuttals and surrebuttals.
- 5. Each team is entitled to divide and allocate time to each speaker of the team in the manner it deems fit, provided that no speaker shall be allocated less than 10 minutes to advance their arguments. This shall be intimated to the Court Master before the commencement of the round.
- 6. The teams must mandatorily reserve a minimum of 2 minutes for rebuttals and sur-rebuttals by the claimant and the respondent respectively and this shall be included within the 30 Minutes time limit.

7. Judges may also exercise their discretion in extending the time for advancing of oral arguments and in determining the method of dealing with such extension of time in scoring the team.

#### D. SEMI-FINAL ROUND

- 1. Qualification to the Semi-Final Round: The four teams that win their respective rounds shall qualify for the Semi-Final Round. In the event of a tie, the same shall be broken by taking into consideration the combined speaker scores of both speakers of a team, across the two preliminary rounds.
- 2. Based on the prescribed rules regarding qualification to the semi-final round, 4 teams shall qualify for the semi-final rounds. The opposing teams shall be decided through a seeding process dependent on the scores of the teams in the Quarter-final Round.
- 3. Each team shall have a maximum of **30 minutes** to advance arguments which includes the time for answering questions, rebuttals and surrebuttals
- 4. Each team is entitled to divide and allocate time to each speaker of the team in the manner it deems fit provided that no speaker shall be allocated less than 10 minutes to advance their arguments. This shall be intimated to the Court Master before the commencement of the round.
- 5. The teams must mandatorily reserve a minimum of 2 minutes for rebuttals and sur-rebuttals by the claimant and the respondent respectively and this shall be included within the 30 Minutes time limit.
- 6. Judges may also exercise their discretion in extending the time for advancing of oral arguments and in determining the method of dealing with such extension of time in scoring the team.

#### E. FINAL ROUND

1. Qualification to the Final Round: The two teams that win their respective rounds shall qualify for the Final Round. In the event of a tie, the same shall be broken by taking into consideration the memorial scores.

- 2. Based on the prescribed rules regarding qualification to the final round, 2 teams shall compete in the final round.
- 3. Each team shall have a maximum of **40 minutes** to advance arguments which include the time for answering questions, rebuttals, and surrebuttals.
- 4. Each team is entitled to divide and allocate time to each speaker of the team in the manner it deems fit provided that no speaker shall be allocated less than 10 minutes to advance their arguments. This shall be intimated to the Court Master before the commencement of the round.
- 5. The teams must mandatorily reserve a minimum of 2 minutes for rebuttal and sur-rebuttals by the claimant and the respondent respectively and this shall be included within the 40 Minutes time limit.
- 6. Judges may also exercise their discretion in extending the time for advancing of oral arguments and in determining the method of dealing with such extension of time in scoring the team.
- 7. The team with the greater total score shall be the winning team of the competition.
- 8. Results for the Final Round of the competition shall be declared during the valedictory ceremony and shall also be announced on the LinkedIn Page, Facebook page and website of the competition. The same shall also be intimated to the teams directly through e-mail.

#### F. SCORING CRITERIA

#### G. ANNEXURES AND COMPENDIUM

- 1. The Annexures and Compendium shall be submitted through the Google Form by 11:59 PM on 10<sup>th</sup> July.
- 2. The Compendium and Annexures should only be sent as single PDF files respectively for easy accessibility of the judges.
- 3. The teams shall make sure that no annexure, document or compendium contains any personally identifiable detail or information including the logo or/and name of institution/college/university or the names of the participants.

#### IX. CLARIFICATIONS

- 1. The teams seeking clarifications either regarding the rules or the moot problem shall send in their queries through the <u>Clarification Form</u> on or before 20<sup>th</sup> June 2022, 11:59 P.M.
- 2. No requests for any clarification shall be entertained post this deadline unless OC deems it fit to address any such query.
- 3. All clarifications will be answered by 23<sup>rd</sup> June 2022 and shall be released for perusal of all teams.
- 4. In case of any delay or change in the responses to the clarifications, the OC shall intimate about the same to the team member who is the official point of contact.
- 5. No queries shall be addressed by any OC member or student volunteer personally.

## X. CODE OF CONDUCT AND PENALTIES

- 1. All participants shall at all times maintain the decorum of the competition.
- 2. No participant shall engage in any form of unethical, unprofessional and wrongful conduct during the competition starting from the registration process till the eventual conclusion of the competition.
- 3. Participants shall not carry or indulge in the consumption of drugs, alcohol, arms or ammunition during the course of the competition.
- 4. Participants shall carry their own reference material which they require for the competition.
- 5. No compendium or annexure handed over to the judges shall violate any code of conduct required to be followed in any manner whatsoever or else severe penalty may be imposed on the team that indulges in the same at the discretion of the OC.
- 6. FORMAL DRESS CODE: Participants shall strictly follow formal dress code during the entire duration of competition provided hereunder:
- For Men: Western black and white formals (white shirt and black tie with black blazer)
- For Women: Western black and white formals (white shirt with black blazer) OR Indian black and white formals (White/Black kurti with a black blazer).
- 7. ANONYMITY: No participant of any team at any time after the commencement of the competition, including during registration, during the continuation of the competition and before its completion disclose the identity of his/her college or institution under any circumstance in any manner including, but not limited to, wearing any identifying items like clothing, ties, patches, pins etc. containing the name or logo of the college or institution that the team is representing or disclosing the name of the team members to the Judges during the competition. In the event, any such disclosure is made, and this rule is violated, the team shall be severely penalized

- and this may involve disqualification. The penalty to be imposed shall be at the discretion of the OC.
- 8. SCOUTING: No member of any participating team shall witness the arguments in any other courtroom in which the team is not participating. In the event this rule is violated, the team shall be severely penalized, and this may involve disqualification. The penalty to be imposed shall be at the discretion of the OC.

The Moot Court proposition is not intended to and does not attempt to resemble any incident or any person living or dead. All material in the problem is fictitious and any resemblance to any incident or person, if any, is not intended, but merely co-incidental.
